| <b>What is the overall <a href="#">deductible</a>?</b>                                | <b><a href="#">In-Network</a>- \$3,500 /individual or \$7,000 /family</b>   | Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .  |
| <b>Are there services covered before you meet your <a href="#">deductible</a>?</b>    | <b>Yes.</b> Preventive Care (as defined in your Member Benefit Agreement). ### Does this plan provide Minimum Essential Coverage? Yes

If you are eligible for certain types of [Minimum Essential Coverage](#), you may not be eligible for the [premium tax credit](#).
